

When travelling to Vanuatu you will be required to undertake 14 full days quarantine upon arrival. You are not required to undertake any period of quarantine prior to your departure from your country of origin.

There may be restrictions on travel and entry for those who are not Vanuatu citizens or residents. Please contact your nearest Vanuatu embassy, high commission or consulate for further information.

As early as possible:

- ✓ Register your intention to travel to Vanuatu and your personal details via the online Vanuatu Electronic Traveler System at <https://covid19.gov.vu/index.php/travelling-to-vanuatu>. You should receive a submission confirmation email address provided. If you do not receive this, check your Junk email folder or contact wwilliams@vanuatu.gov.vu
- ✓ For those who are not Vanuatu citizens, you must fulfill any other exit approvals or requirements of your country of citizenship or travel origin.
- ✓ For those who are not Vanuatu citizens, ensure sufficient funds are available to pay for the full cost of 15 nights of accommodation in a shared room and food at a government-mandated quarantine facility (up to 130,000 vatu per person, depending on the allocated facility)

At this stage, basic quarantine cost for Vanuatu citizens will be met by the Government of Vanuatu. However, this may be subject to change and should be confirmed prior to travel.

72-24 Hours Prior to Travel:

- ✓ Depending on where you are travelling from and through, you may be required to have a COVID-19 test before travel, including children. Refer to <https://covid19.gov.vu/index.php/travelling-to-vanuatu> to find out if you need to have a COVID-19 test before travel.
- ✓ All passengers must complete the Health Declaration section of the Vanuatu Electronic Traveler System at <https://covid19.gov.vu/index.php/travelling-to-vanuatu> and **ensure you upload your negative COVID-19 test result if required**. One Declaration must be completed for each traveler, including children. You should receive a submission confirmation email to the email address provided. If you do not receive this, check your Junk Mail folder or contact wwilliams@vanuatu.gov.vu
- ✓ The Health Declaration is used by the Government of Vanuatu to issue health clearance and approval to travel; you will not be permitted to board a flight to Vanuatu if this has not been completed.
- ✓ Ensure that all essential items (including medication/medical equipment, toiletries, special dietary items, money, electronics and other high value items) plus a change of clothes are packed in your carry-on luggage, as there may be delays with check-in luggage reaching your room.
- ✓ Clearly mark all check-in and carry-on luggage with your name, flight number and contact details.
- ✓ Bring one or more face masks that meet WHO standards, as these must be worn in the airport from the period prior to boarding the flight to Vanuatu until you reach your room at the allocated quarantine facility in Vanuatu.
- ✓ If the allocated quarantine facility (hotel) is known, liaise directly with hotel management for any specific accommodation or dietary requirements
