Refund	Refunds permitted.	• Apply for refund and refer to Commercial Policy Number VUCOM2406.
No-Show	<ul> <li>Guests who no-show on flight – rebook onto new flight (rebook options apply).</li> </ul>	<ul> <li>NO-SHOW fee applies.</li> <li>Reissue ticket into the same RBD, fare difference and change fees apply, and rebook with authority VUCOM2406.</li> </ul>

## **Commercial Policy Conditions**

- Flights no longer required must be cancelled prior to scheduled departure.
- All Air Vanuatu flight changes need to be actioned (reissued) prior to travel
- All other rules and conditions of the ticket remain unchanged.
- Once a ticket has been reissued using this authority, subsequent changes are subject to fare rules and conditions (unless covered by this or another commercial policy).

## For customers with unticketed bookings:

For unticketed bookings, alternate flights/routings can be rebooked subject to availability and tickets issued in accordance with fare conditions.
